TERMS AND REGULATIONS

ART. 1 - EVENT. The Promoting Committee **La Topolino va ai 90** announces and organises a tourist-cultural event for veteran cars called 'La Topolino va ai 90' on **11-14 June 2026** to celebrate the 90th anniversary of the presentation of the FIAT 500.

ART. 2 - ELIGIBLE CARS. Only cars from the industrial production and derivatives of the FIAT 500 built between 1936 and 1955 and industrial productions and derivatives under licence (NSU, Simca, Steyr, Polsky Fiat, etc.) are eligible for the event.

ART. 3 - ROUTE AND PROCEDURE. The route of the event has a total length of approximately **120 kilometres**. There will be no time checks of any kind, except for the indication of an approximate time of arrival at the location(s) chosen as the meeting point, exhibition venue and/or stage. These times should not pose any difficulty in terms of adjustment and failure to comply with them will have no consequences. The event will take place in all weather conditions. In the event of road obstructions, particularly adverse natural circumstances or in all cases of force majeure that may constitute a danger or inconvenience, even potential, that may occur before the start or during the event, the organisers may, at their sole discretion, change the programme and the running of the event to protect the safety of participants and third parties, as well as the cars.

There will be no refueling stops. Cars must have a full tank of gas before the start of the event and before each daily departure.

ART. 4 - ADVERTISING ON CARS. Advertising on cars is limited to a space to be defined by the Organising Committee and cannot be refused by participants. No other form of advertising may appear on the vehicles unless it has been previously accepted and authorised, with the sole exception of any original livery referring to the specific chassis number, for which proof of authenticity must be provided. Team and club emblems and lettering are permitted.

ART. 5 - BEHAVIOUR. Throughout the event, drivers must comply with all traffic regulations and the instructions given by the event organisers, and must drive in a conscious and prudent manner. **Cars displayed in reserved areas, even by virtue of collective authorisation issued by the competent authorities, may not be moved before the scheduled departure time. If necessary, the organisers and the police must be notified in advance of any removal.**

ART. 6 - REQUIREMENTS. Vehicles must meet all the requirements of the Highway Code and therefore be equipped with valid registration documents.

ART. 7 - REGISTRATION. Registrations, made on the appropriate form, completed in full and signed to indicate knowledge and acceptance of these Regulations, must be received, together with a photocopy of the payment of the fee, by the **deadline of March 15th 2026**, by email to info@topo90.it.

The fee includes hospitality from the welcome on Thursday 11 June 2026 to lunch on Sunday 14 June 2026, excluding lunch on Thursday and Saturday. Anything not expressly specified is to be considered the responsibility of the participant. The Organising Committee reserves the right, at its sole discretion, to accept or reject applications for membership.

ART. 8 - RIGHT OF WITHDRAWAL. The right of withdrawal may be exercised, for any reason, by written communication via email, fax, telegram or letter, which must be received by the Committee's headquarters within the deadline set for registration. In this case, the entire amount paid for participation will be refunded without penalty. If the right of withdrawal is exercised after the registration deadline, or in the event of failure to attend or for any other reason, a penalty equal to the deposit provided for in the agreements entered into from time to time with the hotels will be retained, in addition to other non-recoverable expenses.

ART. 9 - GENERAL PROVISIONS. By registering for the event, each participant declares, on their own behalf and on behalf of their passengers or representatives, that they are aware of and accept the provisions of these Regulations, and therefore consider the Automobile Club Storico Italiano (A.S.I.), the Fédération Internationale des Véhicules Anciens (F.I.V.A.), the Organising Committee and all persons involved in the organisation or otherwise interested in the event, the bodies and associations collaborating with and sponsoring the initiative, the natural and/or legal persons involved during the event, as well as the owners and managers of the routes and public and/or private areas, from any liability for any damage occurring during the event.

ART. 10 - MISCELLANEOUS. For anything not covered or provided for in these Regulations, consisting of 10 articles, the provisions of the Civil Code shall apply.
